

What is Social Justice?

- ▶ Social justice promotes efforts to empower individual and communal action in supporting historically disadvantaged and marginalized groups.
- ▶ It recognizes that the legacy of past injustices remains all around us, and it encompasses efforts to end systemic violence, racism, and all systems that devalue the dignity and humanity of any person.

▶ Access to Resources

- Healthcare, food, housing, education, recreation

▶ Equity

- Ensure fair and impartial access for all

▶ Participation

- Increase visibility and civic engagement

▶ Diversity

- Ensure representation of women of African descent in all segments of society

▶ Human Rights

- Civic, political, economic, cultural, legal

NCNW Principles and Social Justice

- ▶ Empower and advocate for Black women and their families
- ▶ Commitment, Unity, Self-Reliance
- ▶ Four for the Future

Role of the National Social Justice Committee

Provide

- Provide a framework for social justice actions and initiatives.

Advise and collaborate

- Advise and collaborate with the Executive Board to drive actions and responses to social justice issues that impact our communities.

Create

- Create sustainable partnerships with our affiliate organizations to address social justice issues.

Assist

- Assist local NCNW sections with social justice initiatives via advisement and guidance in creating actionable steps to advance justice.

Ladder of Social Justice Engagement

Create

- Educational or fundraising activity for a social justice cause

Attend

- An informational program to take action for a social justice cause

Participate

- In a letter writing or phone banking campaign to address a social justice issue

Host

- A community gathering to address a social justice issue

Boycott

- A business or event to increase awareness about a social justice issue

Protest

- Gather or march in protest to address a social justice issue

Recommendations for NCNW Sections

Establish

- Establish a Social Justice Committee.

Review

- Review the National NCNW Social Justice Committee Mission, Vision, and Values statement and participate in activities to support this mission.

Identify

- Clearly identify actionable steps that each Section will engage based on the Principles of Social Justice and the mission of NCNW.

Partner

- Partner with local affiliates to collaborate on a social justice activity that will benefit the local community.

Connect

- Connect with local leaders in the community to build ongoing communication and address social justice issues.
